## 13th CARNIVOROUS ARTIFICIAL BAIT BOAT ANGLING WORLD CHAMPIONSHIP 2020 Zegrzyńskie Lake, Poland

### PERIOD OF THE EVENT

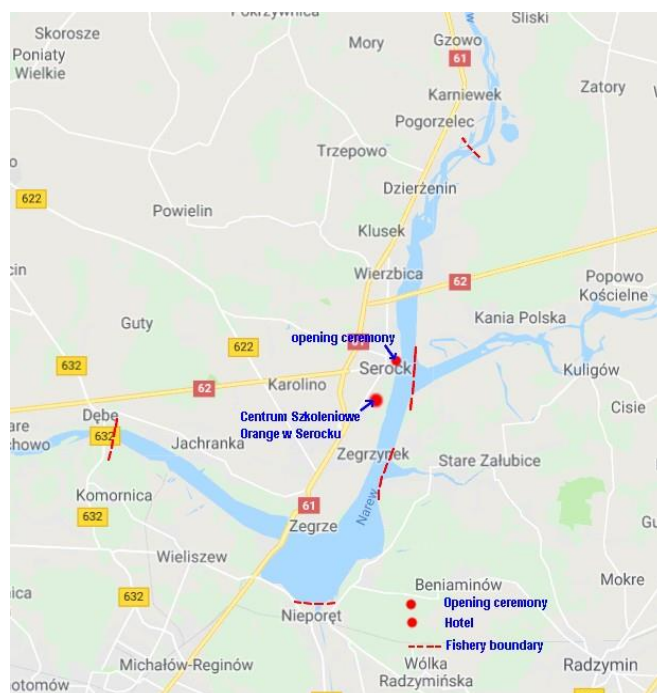
From Monday, October the 5th 2020 (arrival of participating Nations)  
To Sunday, October the 11th 2020 (departure of participating Nations)

**Each nation must bring their own national flags (2 pieces measuring 2 x 1.65m) as well, their national anthem on a CD or USB stick.**

### COMPETITION VENUE

The competition will take place at Zegrzyńskie Lake created in the result of water damming on the river Narew located about 30-40 km north of Warsaw (the capital of Poland). The Serock town where the competition office will be located lies by the northern part of the lake and is one of the oldest cities in Mazovia (1065). The competition venue can easily be reached from the main roads. The tributaries of the Bug and Rządza rivers (eastern side of the reservoir) as well as the Żerański Channel (southern lake side) will be excluded from fishing.



## Characteristics the fishery area

The Zegrzyńskie Lake created in 1963 in the result of water damming on the river Narew after dividing the riverbed in Dębe and has approximately 3300 hectares of the water surface and is bordered by natural vegetation. Depth range is up to 11 meters.

The lagoon is a bit like a river, a bit like a lake. There is a weak current above the old riverbed, especially in the part of the Narew River. Access to the water is protected by a several-meter reed belt. Most of the shallows are overgrown with yellow waterlily colonies, here and there you can find clusters of bulrush, calamus and other typically lake plants. In the central part, on the bowl of the reservoir, there are a lot of smaller and smaller pits, as well as underwater hills with hard slopes, dotted with bark, claws and seabeds. In addition to many carp species, the reservoir has a large population of predatory fish: perch, pike, zander and asp.

Arrival at Warsaw Chopin Airport and then by car to the place of the championship. The distance is about 43 km.

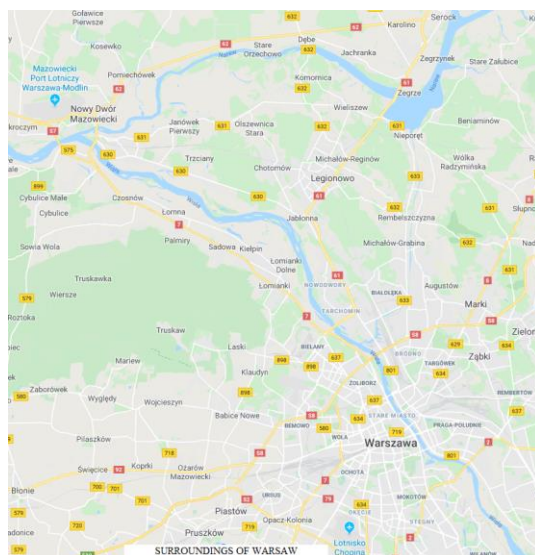
Arrival at Warsaw-Modlin Airport and then by car to the place of the championship. The distance is about 32 km.

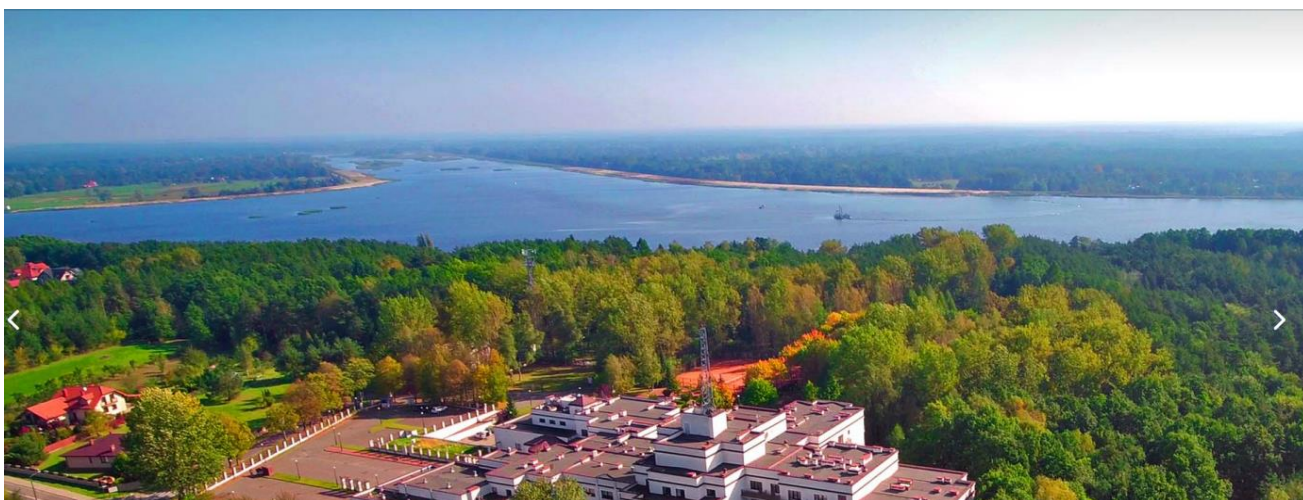

# ANTI-DOPING INFORMATION TUE REQUESTS

A Therapeutic Use Exemption (TUE) is a certificate granted by an anti-doping organization (IF for international-level athletes, NADO for national-level athletes and MEO for athlete participating in an MEO event). The certificate is for a set prohibited substance, in certain dosages, with a limited period of validity. An application for a TUE must be based on a documented medical condition and diagnosis and the TUE will only be granted under strict criteria laid out in the International Standard of TUEs.

**Athletes must absolutely avoid taking a medication with a prohibited substance without a valid TUE.**

The presence of a prohibited substance or its metabolites or markers in an athlete's sample without a valid TUE is an Anti-Doping Rule Violation (ADRV), as are the use or attempted use of a prohibited substance or a prohibited method, possession, administration or attempted administration.

Athletes must therefore consult the Prohibited List <https://www.wada-ama.org/en/resources/science-medicine/prohibited-list> with their prescribing physician before taking a medication to ensure that no prohibited substance is contained in the medication needed.

Athlete whose illness or condition requires treatment with a prohibited substance or method (listed in this link: <https://www.wada-ama.org/en/resources/science-medicine/prohibited-list>) must apply to CIPS for a TUE following the CIPS strict **TUE application process**. He shall then use the application form, which can be downloaded from the ITA website: <https://ita.sport/wp-content/uploads/2019/02/TUE-Form.pdf>

If the TUE is granted, the athlete will then be permitted to use the medication during the period of validity of the TUE without committing an Anti-Doping Rules Violation (ADRV).

Regardless of whether a TUE has been granted or not, athletes should always declare on the doping control forms filled out during sample collection any medications and supplements taken within the seven days prior to sample collection, and any blood transfusions in the three months prior for blood samples.

If a TUE has already been granted by a NADO or by a RADO, the Athlete in question does not have to apply for any additional CIPS TUE, as CIPS recognizes all TUE granted by NADOs and RADOs.

## VISAS

Citizens of all European countries that are members of the Schengen area (EU member states and Iceland, Norway and Switzerland) do not need entry visas to Poland. Visas for citizens of other countries can be obtained at Polish consulates, in the countries of residence.

## **VISA SUPPORT**

Please be advised that citizens of many countries need a visa to visit the Poland. The organizers can provide visa facilitation if requested in advance.



## PAYMENTS - CURRENCIES

The Polish currency is the Polish Zloty (PLN). Foreign currencies can be exchanged at any bank and exchange office. Card payments are generally accepted, but not everywhere.
